**RE: Notice of Termination of the ATCA Hunting Working Committee**

Dear David:

This law firm represents the Airedale Terrier Club of America ("ATCA") Board of Directors ("Board"). On October 3, 2007, the Board conducted a meeting. On that date, the Board voted to immediately terminate the Hunting Working Committee pursuant to the ATCA Constitution, Article V, Section 1.

Although the Hunting Working Committee ceases to exist, you and your former Committee members retain ATCA membership status and privileges. The status and privileges will continue in the absence of your resignation by your membership lapsing, or by expulsion pursuant to the Constitution Article I, Section 4. As ATCA members, you now have some critical duties to the ATCA that must be carried out immediately.

First, all Hunting Working Committee property and assets including, but not limited to, cash, check books, credit cards, financial records, sales inventory, trophies and awards, meeting records, trial manuals and materials ("property and assets") must be promptly returned to the Board. Please prepare a complete and detailed list of all property and assets that are in the possession of the Hunting Working Committee. As soon as this is complete, please contact Virginia Latham Smith or me to make arrangements to transfer the ATCA property and assets back to the Board.

Second, please provide a complete and detailed list of all events that have been planned or scheduled by the Hunting Working Committee or any of its members under the ATCA's name. The Board's resolution canceled all Hunting Working Committee events. The ATCA's insurance carrier has been notified and will not provide coverage for any events that have not been authorized by the Board.


Third, please provide a complete and detailed list of all outstanding contracts that have been entered into by the Hunting Working Committee or any of its members on behalf of the ATCA. The Board has obtained copies of contracts for events at the Cherry Valley Lodge for 2008, 2009, and 2010. There is also good reason to believe that other contracts may have been entered into for hunting events and related activities.

The Board is willing to assign any or all of these contracts to individual former Committee members or any other entities of your choice. Otherwise, the Board will notify Cherry Valley Lodge and other entities in the near future that the Board did not authorize the contracts and that those persons who signed the contracts should be pursued individually. Please note that the 2008 Cherry Valley Lodge Contract can be canceled 120 days before the event, which is November 27, 2007. Accordingly, please notify me by the close of the business day on November 26, 2007 if you would like the 2008 Cherry Valley Lodge Contract to be assigned to another individual or entity.

Time is of the essence on each of these items. This correspondence is being provided to those who, according to the Board's best knowledge, were the Hunting Working Committee members as of October 3, 2007. We are hopeful that the former Hunting Working Committee members will cooperate with the Board in completing these objectives.
