This test is held under the *Fur Tracking and Trailing Test Regulations* of the Airedale Terrier Club of America.

RETRIEVER TEST

Judges: Kyle Inks & Scott Lichty

There will be a test dog.

Ducks will be used for land and water portions of the test.

These tests are held under the *Retriever Test Regulations* of the Airedale Terrier Club of America.

The Fur Tracking and Trailing Test is open to Airedale Terriers six months of age or older on the first day of the event.

Fur titles awarded AKC Parent Club Fur Tracker titles will be awarded to dogs that qualify.

Entry is limited to fifteen (15) entries. Entries will close when the limit is reached, if this occurs prior to specified closing time.

Entry Fee is \$30 per dog, Junior, Senior or Master. Entries must be signed and filled out completely. Checks payable to 'ATCA' must accompany all entries.

The Retriever Test is open to Airedale Terriers six months of age or older on the first day of the event.

Participation by mixed-breed dogs or other breeds may be granted by the Hunt Test Committee. If approved, these breeds may enter For Exhibition Only, by paying the full price of the entry. Titles may only be earned by Airedale Terriers.

Entry is limited to fifteen (15) entries. Entries will close when the limit is reached, if this occurs prior to specified closing time.

Entry Fee is \$45 per dog, Junior or Senior. Entries must be signed and filled out completely. Checks payable to 'ATCA' must accompany all entries.

Camo or dark clothing is to be worn during Retriever Tests.

Running orders will be decided by a drawing and will be posted prior to the test. Dogs handled by the same person shall be separated when possible. Dogs may be run in a different order than drawn if the change will result in a reasonable and desirable savings of time.

All entries will close at noon CDT, on Saturday May 6, 2023, with the Hunt Test Secretary. No telephone entries will be accepted. Walk-up entries may be allowed. Signatures must be waived on carrier delivered entries. The running orders for the Fur Tracking and Trailing Tests will be emailed to all entrants that include an email address on their entry form. Running orders for the Retriever Tests will be posted prior to the test.

Refunds/ Scratches/ No Shows Entry fees paid for a bitch withdrawn because of coming into season or for a dog withdrawn because of an injury or illness, or for a dog which dies, shall be refunded in full by the test giving club. Prior to paying such refund, the club may require an appropriate veterinary certificate. Requests and documentation must be presented prior to the test. There will be no refunds for "no shows." Entry fees will not be refunded in the event a dog is disqualified, excused by a judge or barred from the test by action of the Hunt Test Committee. No entry fee will be refunded if the test cannot be started or completed by reason of riots, civil disturbance, an act of God, public emergency, or any other cause beyond the control of the Hunt Test Committee.
